### **Terms and Conditions of OLMUN 2025**

#### 1. Appliance

For participation in the Oldenburg Model United Nations Conference 2025 (simply referred to as OLMUN 2025), the following terms and conditions apply exclusively in the version valid at the time of application.

The parties to the agreement on participation in OLMUN 2025 are the Oldenburg Model United Nations Association, represented by the Secretary General Emily Roshop, Im Uhlenhorst 4, 26135 Oldenburg (**OLMUN e.V.**) and the registered natural or legal person (**participant**).

By applying, the participant accepts the Terms and Conditions. OLMUN e.V. does not recognize any deviating terms and conditions of the participant unless the OLMUN e.V. agrees to their validity in writing. Individual agreements have priority (§ 305b BGB).

The MUN-Director is responsible for ensuring that each individual participant in his/her group or his/her legal guardian receives and accepts these terms and conditions. The signed copy must be received by OLMUN e.V. from each participant by March 31, 2025 at the latest.

All participants of the OLMUN conference must follow these terms and conditions, as well as all instructions of the responsible persons of OLMUN e.V. Misconduct may lead to exclusion from the conference.

#### 2. Scope of Validity

These terms and conditions apply to all OLMUN 2025 events, including the Opening and Closing Ceremony, the Committee Sessions and an optional evening program.

#### 3. Application and Conclusion of Contract

Applications are possible until 15.03.2025. The presentation of an event in the event database, on the OLMUN website or the sending of event information does not constitute a legally binding offer (invitatio ad offerendum).

The application for OLMUN 2025 can only be made as a group with the declaration of a representative, called MUN-Director. Application and participation as delegate or staff are subject to a maximum age limit of 21 years at the time of the conference.

The Application for participation in OLMUN 2025 consists of various processes that can only and exclusively be carried out on the homepage (https://www.olmun.org):

- 1. The MUN-Director registers himself and his school on the website
- 2. The other group participants register, stating their school.
- 3. Each participant in the group sends the signed terms and conditions by e-mail to secgen@olmun.org. In the case of participants under the age of 18, the terms and conditions must also be signed by a parent or legal guardian.
- 4. The MUN-Director verifies the applications for his/her school.

The applicant submits a legally binding offer to OLMUN e.V. by applying on the website and additionally sending the signed terms and conditions by e-mail to secgen@olmun.org. The contract for participation in the event is concluded upon receipt of a confirmation of participation from OLMUN e.V.. The languages available for the conclusion of the contract are German and English.

#### 4. Description of Services

The object of the service is participation in OLMUN 2025.

The accommodation and catering of the participants with drinks and food is not part of the service, unless an additional Application for the Housing Program has been made.

Deviations from the details of the event are permitted after confirmation of participation, as long as the change or deviation is reasonable, taking into account the interests of the participants.

#### 5. Participation Fees

The participation fee is EUR 40.00 per delegate. Teachers can attend the conference free of charge for groups of five or more delegates.

The participation fee is due upon conclusion of the contract and must be paid by the date stated in the invoice at the latest, stating the invoice number. Payment of the participation fee must be made free of charge exclusively to the account specified in the invoice.

OLMUN e.V. has the right to refuse services until the participation fee has been paid entirely.

The participation fee is also due if the registered participant does not attend the event.

#### 6. Refunds

Individual participants are not entitled to a refund of the participation fee.

Groups that cancel their participation within six weeks before the first day of the conference will be refunded 50% of the participation fee.

Full refunds will only be made if OLMUN e.V. is unable to provide accommodation for participants of the Housing Program and if this is the reason why the group cannot attend OLMUN 2025.

OLMUN e.V. cannot guarantee refunds for purchased public transportation tickets.

#### 7. Cancellation

OLMUN e.V. is eligible to cancel OLMUN 2025 if the realization of OLMUN 2025 becomes impossible for reasons OLMUN e.V. is not responsible for. This is particularly the case if force majeure makes it impossible for OLMUN e.V. to carry out OLMUN 2025.

OLMUN e.V. will announce the cancellation in good time before the start of the event. The obligation to pay shall lapse with the cancellation. Participation fees already paid will be refunded. Further claims are excluded, except subject to point 10.

#### 8. Housing Program

Only groups from abroad or from so-called "international schools" are eligible for the housing program. All participants should be at least 16 years old. Exceptions may be considered on request.

In select cases, OLMUN e.V. reserves the right to admit other groups to the housing program as well.

The Housing Program is free of charge.

OLMUN e.V. may be forced to cancel the housing program if not enough host families can be found.

The host families provide the participants with breakfast and, if possible, an evening meal. A suitable sleeping situation will be provided.

Participants of the housing program must at all times comply with the rules of the respective host family, as well as with the legal requirements (especially with regard to the consumption of alcohol and tobacco products). Violations of these rules may result in expulsion from the housing program.

Neither OLMUN e.V. nor the host families are responsible for the actions of the participant.

Participants of the housing program must purchase public transport tickets for the Oldenburg region.

#### 9. ÖPNV-Tickets

Tickets for public transport can be purchased by a MUN-Director for the participants of his group via OLMUN e.V.

Public transport tickets are limited and only valid for the four conference days.

The general terms and conditions of the transportation companies apply. OLMUN e.V. is neither responsible nor liable.

#### 10. Liability

OLMUN e.V. is liable for damages resulting from injury to life, body or health as well as for damages caused by intent or gross negligence on the part of OLMUN e.V. or its legal representatives or vicarious agents, as well as for damages in the event of non-compliance with a given guarantee.

OLMUN e.V.'s liability is limited to compensation for foreseeable damage typical of the contract for damage caused by a slightly negligent breach of essential contractual obligations by OLMUN e.V. or

its legal representatives or vicarious agents. Essential contractual obligations are obligations whose fulfilment is essential for the proper execution of the contract and on whose compliance the participant may regularly rely.

Further claims for damages are excluded.

The provisions of the Product Liability Act remain unaffected.

The restrictions of the above provisions shall also apply in favour of the legal representatives and vicarious agents if claims are asserted against them.

#### 11. Protection of Minors

During OLMUN 2025, the legal regulations of the Youth Protection Act of the Federal Republic of Germany apply. The Youth Protection Act (Jugendschutzgesetz) can be viewed at www.olmun.org. At the private events of OLMUN 2025, all participants who meet the participation requirements may also participate after 24:00. Participants who have not yet reached the age of 18 may only return to their accommodation after 24:00 if accompanied by an adult supervisor.

The MUN directors are responsible for compliance with the provisions of the Youth Protection Act and for the safe return of the participants to and from the events. OLMUN e.V. is not responsible or liable for safe transportation to and from the events.

#### 12. Right of Withdrawal for Consumers

**Consumers** have a fourteen-day right of withdrawal.

#### Right of Withdrawal

#### **Right of Withdrawal**

You have the right to withdraw from this contract within fourteen days without giving any reason. The withdrawal period is fourteen days from the date of conclusion of the contract.

To exercise the right to cancel, you must inform us (OLMUN e.V., Im Uhlenhorst 26135 Oldenburg, E-Mail: secgen@olmun.org) of your decision to cancel this contract by a clear statement (e.g. a letter sent by post or e-mail). You can use the attached sample withdrawal form, but this is not mandatory.

To meet the withdrawal deadline, it is sufficient for you to send your notification of exercising your right of withdrawal before the withdrawal period has expired.

#### **Consequences of Withdrawal**

If you withdraw from this contract, we shall reimburse to you all payments received from you, including the costs of delivery (with the exception of the supplementary costs resulting from your choice of a type of delivery other than the least expensive type of standard delivery offered by us), without undue delay and in any event not later than 14 days from the day on which we are informed about your decision to withdraw from this contract. For this repayment, we will use the same means of payment that you used for the original transaction, unless expressly agreed otherwise with you; in no case will you be charged any fees for this repayment.

If you have requested that the services should commence during the withdrawal period, you must pay us a reasonable amount corresponding to the proportion of the services already provided by the time you inform us of the exercise of the right of withdrawal with regard to this contract compared to the total scope of the services provided for in the contract.

#### 13. Data Protection

The data of the participant or their representative will be electronically stored and automatically processed in accordance with Art. 6 para. 1 sentence 1 lit. b GDPR exclusively for the purpose of organizing the event by OLMUN e.V. as the responsible party within the meaning of Art. 4 No. 7 GDPR.

The data will be deleted as soon as it is no longer required to achieve the purpose for which it was collected. This is the case when OLMUN 2025 has been completed. The implementation includes the sending of confirmations of participation or any documents, insofar as this is part of the contract.

Data may also be stored if this has been provided for by the European or national legislator in EU regulations, laws or other provisions to which the controller is subject.

The data will not be passed on to unauthorized third parties unless express consent is given to any other use and/or use of the data specified in the respective consent in accordance with Art. 6 para. 1 sentence 1 lit. a GDPR. The use then also includes the forwarding of the data to third parties covered by the respective specific consent.

Further information on data protection, in particular on the rights to which you are entitled as a data subject, such as the right to information, the right to rectification or erasure, the right to restriction of processing, the right to object to processing, the right to data portability, the right to withdraw consent and the right to complain to a data protection supervisory authority about the processing of your personal data by us, can be found at <a href="https://www.olmun.org">https://www.olmun.org</a>.



#### 14. Final Conditions

The language available for the conclusion of the contract is German and English. The legal interpretation of the contract shall be based on the German version of the terms and conditions.

The contractual relationship between OLMUN e.V. and the participant shall be subject to the law of the Federal Republic of Germany to the exclusion of international uniform law.

Amendments, additions, the cancellation of the contract and ancillary agreements must be made in writing to be effective. This also applies to the amendment of this written form clause.

The place of fulfilment for all mutual claims is Oldenburg.
